The proxy must be submitted to the WFASD Executive Office no later than 10 days before the WFASD General Meeting.

WFASD national federations members, which have no outstanding debt can be represented by Delegates, who will be entitled to vote. Individual members, with no outstanding debt to WFASD, are entitled to vote as well.

Questions, motions addressed to the next WFASD General Meeting and to be included in the agenda shall be submitted together with a brief explanation to the WFASD Executive Office at least 2 months before the WFASD General Meeting.
