**Agenda item 2:** Extension of judges' licenses for Acrobatic Rock'n'Roll and Acro-Swing.

- November 23, 2025, World Cup in Acrobatic Rock'n'Roll and Acro-Swing, Moscow (Russian Federation);
- December 20, 2025, World Championship in Acrobatic Rock'n'Roll and Acro-Swing, Abu Dhabi (United Arab Emirates).
