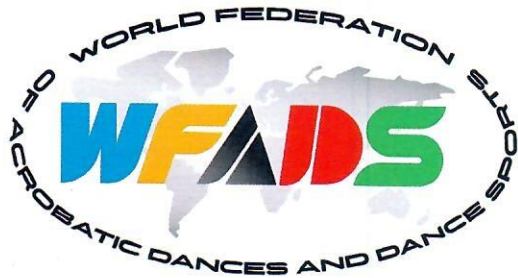
**Voting result:** The motion passed unanimously.
